

MINUTES OF THE NOVEMBER, 2020 MEETING OF
THE LEBANON 9-12 PROJECT

Prior to the call to order, Jim explained to the members the situation with the election holdover, due to the inability to meet for most of 2020. A vote was taken and the membership unanimously agreed that the current board members would continue in that role for 2021.

want answers now but we are going to have to be a little patient with those who are fighting for us so they can do exactly that, fight for us.

I witnessed a young woman turn up at a recent local event and that person went off on Frank Ryan, screaming at him. I understood her frustration but that's misdirected anger. Where are those same displayed with Tom Wolf, Rachel Levine and Kathy Boockvar or against the judges like David N. Wecht who are legislating from the bench.

I can tell you that an impeachment resolution has been filed against Wecht and if you want to know who the good guys are in the house, the 35 names on that bill are a good start, (RYAN, DIAMOND, BOROWICZ, EVERETT, NELSON, ROWE, GLEIM, GROVE, METCALFE, RIGBY, MACKENZIE, COOK, IRVIN, MARSHALL, DAVANZO, KEEFER, TOPPER, JONES, SCHEMEL, CAUSER, OWLETT, GREGORY, KNOWLES, DUSH, KINSEY, FRITZ, MILLARD, SANKEY, WARNER, SCHMITT, STAATS, ZIMMERMAN, HEFFLEY AND MOUL). The bill is House Resolution 1044, go home and look it up.

The swamp is real, the deep state is real and it's bigger than the Everglades. It isn't just people in elected power. The appointed administrations is infested with those who would advance the globalist agenda for their own personal gain. They're coming for you. They aren't going to stop with Donald Trump. When we came together almost 12 years ago, most of us knew this was not going to be a short journey and that there would be a lot of work needed to restore these principles of life, liberty and property. To that end, I'm thankful for those groups who have endured along side us, working to the same goals to the same end. That we and groups like us have endured is a testimony of the perseverance of all who have stood with us.
